1 Environmental Stewardship Policy

We at Kennametal are aware that environmental responsibility is a requirement for both societal and economic well-being and sustainable economic progress. We believe that environmental issues are interconnected at the local, regional, and global levels. We are determined to address problems like pollution, biodiversity conservation, sustainable resource use, and climate change (mitigation, adaptation, and resilience) in a fair, thorough, and systematic manner.

1.1 Commitment

To adopt environmental practices and processes that minimize, mitigate and eliminate the adverse impacts of our operations, products and process on the environment and society.

1.2 Scope and boundary

This policy statement is applicable to all our functional units and shall be applied during each stage of our value chain *(Applicable to Indian operations)*.

1.3 Objective

The objective of this policy statement:

- 1. Uphold the guidelines provided in our EHS policy and assess the nature, scale and environmental impacts of our business operations and products, especially when operating in eco-sensitive areas as defined by SEBI.
- 2. Commit that we abide by environment laws and other requirements to protect environment by taking actions to prevent pollution, for natural resource conservation and efficient consumption.
- 3. Develop structure to identify environment objectives; monitor and document their measurable performances to communicate publicly.
- 4. Establish framework to facilitate continual improvement of the environmental performance.
- 5. Identify measurable environmental KPIs while giving due consideration to stakeholder consultation.
- 6. Support India's Nationally Determined Contributions for addressing climate change through adaptation and mitigation activities as mandated by local regulations from time to time.
- 7. Work towards developing and adopting procedures to reduce, reuse and recycle and promote it amongst our stakeholders, especially consumers and business partners.
- 8. Continuously engage with and invest in solutions and R&D to identify resource-efficient and low-carbon technologies and solutions resulting in a lower resource footprint, lesser material consumption and a more positive impact on the environment, economy and society.
- 9. Build competency on environment compliance and management through regular monitoring and training.
